

**John Jenkins Photography  
Wedding Photography Agreement**

**Terms of Business - Version July 2010 (v2)**

This constitutes an order for wedding photographs, prints and/or albums.  
This version of Terms of Business supersedes any previous version.

**UK COPYRIGHT:** Copyright, Designs and Patents Act 1988 assigns copyright to John Jenkins Photography. You may not copy the photographs taken under this contract, or allow copies to be made photographically, electronically, or by any other means. Unless agreed with John beforehand.

It is understood that any and all proofs, sample prints and data files remain the property of the photographer, John Jenkins, and they may be used for advertising, display or any purpose thought proper by John Jenkins.

If **DIGITAL FILES** are purchased by the Clients it is understood that the user agreement is for personal use only, both prints and digital files. Any and all commercial use or sale of the files and/or prints is prohibited under this agreement. Digital files will be provided in a light balanced and colour corrected printable format. This does not include any air brushing, image manipulation or enhancement. All additional Photoshop work is chargeable. Digital enhancement of web gallery images is provided at John's discretion and such files must be purchased separately.

**CREATIVE LICENCE:** John Jenkins Photography shall be granted creative and artistic license in relation to the choice of locations and poses used. John's judgment on photographic style and the number of photographs taken shall be deemed correct. Due to changes of the weather and the availability or willingness of subjects, John will do his best to honour requested photographs but does not undertake to guarantee any specific picture nor incorporate any specific background, location or group arrangement.

Every effort will be made to capture photographs of your wedding service. However, this at the discretion of the authorised individual performing the ceremony. Therefore, photographs of the service cannot be guaranteed but will be captured if circumstances allow.

**EXCLUSIVITY:** John will be the sole professional (still) photographer at the venues specified. It is understood that no other professional photographer or professional photographic equipment shall be allowed to photograph the wedding. No photographs are to be taken while the Photographer John Jenkins and/or associates are working. Therefore, guests may be politely requested to temporarily stop taking photographs when this may impede John's photographic work. The Clients will ensure that guests do not interfere with the Photographer's work. However, guests will be given plenty of opportunity to take photographs throughout the day. It is also understood that any breach of this agreement will constitute a reason for non-completion of the job with no liability to the Photographer John Jenkins and loss of fees paid in respect to this agreement.

**Pre-Wedding Shoots**

If a Pre-Wedding Shoot is included in your package then this must be arranged Monday to Thursday between the hours of 10am - 4pm at least 3 months prior to the wedding date or as soon as possible after booking if less than 3 months remain. The shoot must take place at the reception venue or wherever the majority of photographs are expected to be taken. It is the responsibility of the bride & groom to co-ordinate this event with John and the venue. If the contracting party are unable to arrange their pre-wedding shoot within these terms then no refund will be made.

**Cancellation**

Should the clients wish to cancel this contract at any time, notice must be given in writing to John Jenkins. In this event the following sums will be due: Notice given less than 16 weeks prior to the wedding date the client should pay John Jenkins a sum equal to 50% of the balance due. Notice given less than four weeks before the wedding date the whole balance of the sum due will be payable with no refund of monies already paid.

**Force Majeure**

In the event of cancellation of this contract by the photographer, due to any cause beyond their control, liability shall be limited to a full refund of all monies paid. Although all care will be taken with the images and photographs taken at the wedding, photographer limits any liability for loss, damage or failure to deliver pictures for any reason, to return of all fees made.

Upon signature with booking fee, Photographer John Jenkins reserves the time and date agreed upon, and will not make any other reservations for that date and time. For this reason, all fees and payments are non-refundable, even if the date is changed or wedding cancelled for any reason. Therefore, it is **strongly recommended** that all clients take out the appropriate wedding insurance.

**A non-refundable booking fee of £250 is due at signing of this contract, with the balance payable two months prior to the date of the wedding.**

All terms of this contract are understood and agreed upon.
